# **EXECUTIVE SUMMARY**

The Chisholm Trail 100 Club, Inc. is a growing network of people working together to provide financial support and encouragement to survivors of eligible law enforcement officers, firefighters, correctional officers and emergency medical service personnel who are killed or seriously injured in the line of duty within our area of operation, Johnson County, Texas. The Club is a citizen sponsored not-for-profit organization created to support the families of First Responder personnel and is funded only by its member dues (e.g. Annual memberships, Lifetime Memberships, etc.) and general donations from the public.

When tragedy strikes the effects can be both swift and devastating. The 100 Club recognizes the need to respond immediately with personal support and understanding. Whatever the need, be it financial, advisory, or moral support, the 100 Club will be there to ease the pain of the family of a firefighter, law enforcement officer, correctional officer or EMS (Emergency Medical Service) responder injured or killed in the line of duty.

# Historical Background

The idea of the first 100 Club began in Detroit, Michigan, in 1952, after a local businessman, William Packer, was moved to action when a police officer was killed in the line of duty. Packer, a friend of the Police Commissioner, wrote to 100 of his friends, encouraging them to donate to a fund for the fallen officer's family to get them through the emotionally and financially trying time. The response was 100% positive.

Packer and the Commissioner later met with the expectant widow, reviewed her finances, arranged to pay off the mortgage on their recently purchased home, pay all the bills, set up an education account for the yet unborn child and deposited \$7,000 in the widow's checking account.

These caring and unselfish actions became the charter for what is now nationally known as "The 100 Club". Over the last 50 years, 100 clubs have been started in cities in every state of the nation and members now number into the tens of thousands.

The Chisholm Trail 100 Club is the newest member to join the other Texas 100 Clubs: The 100 Club, The 100 Club of Southeast Texas and the 100 Club of Central Texas.

As clubs grew, their missions expanded and changed. Many clubs have elected to include Fire Fighters and EMS Personnel; some have even begun providing stipends to qualified agencies to purchase equipment to enhance the safety of their personnel.

The 100 Club Members realize that money can never make up for the loss of or disability of a loved one, but it can be helpful in covering immediate expenses. In addition, the 100 Club has a committee of experts, a Professional Advisory Team including members of the Fallen Officers' Agency, CPAs, attorneys, trust officers, brokers, financial consultants and employee benefits consultants. This team, at the survivor's request, will advise and counsel the family in a wide range of areas without cost or obligation.

If you are a civic minded individual and support the 100 Club mission, there is a place for you among this group of extraordinary people. Membership in the 100 Club is open to everyone and provides minimum effort and maximum satisfaction. We simply want to help those who are always there to protect us.

# A LETTER FROM OUR PRESIDENT

July 17, 2015

To our Chisholm Trail 100 Club Members:

Welcome to our 5<sup>th</sup> annual meeting of or Chisholm Trail 100 Club. I want to thank every one of you for the tremendous support you have shown to our first responders. With your support we, together, are all able to provide resources to first responder families in the event our community experiences a line of duty death or serious injury of a first responder.

I also would like to thank our dedicated Board of Directors, Advisors and our Executive Director, Niki Passmore. This phenomenal leadership team is one that you all can be proud of for its



leadership and commitment to this organization. At a recent gathering of 100 Clubs from across the State of Texas, the dedication and forward thinking leadership of our Club became very evident as The Chisholm Trail 100 Club was the benchmark by which all of the other clubs were measured; clubs with considerably more resources, longer tenure, larger memberships and bigger territories, recognized the energy, programs, systems and technology of our Club and the phenomenal success we have achieved.

Enclosed in this annual report are the financial records of The Chisholm Trail 100 Club. The financial performance for the year was steadfast in its goal toward excellence. The Chisholm Trail 100 Club will continue to provide a \$50,000 line of death policy for all of our first responders.

During last year's annual meeting our keynote speaker John Calandro challenged our club to set up a scholarship fund for the children of fallen first responders. In his challenge he offered to match the first \$10,000 dollars raised by the Club. We are pleased to report we now have the *John Calandro Scholarship Fund* with over \$34,000 dedicated for scholarships to dependents of fallen first responders. Mr. John Calandro and his brother were beneficiaries of a Michigan 100 Club's scholarships when their father John Calandro, a police officer, was killed in the line of duty. Many thanks to John for his support, and vision and to the many donations our members have contributed to this fund.

As I enter the second year of my term, I would like to share with you several major initiatives we are working on;

- Continue to grow our endowment account in order to be able to reduce our reliance and expense for insurance policies for our first responders.
- Strive to build stronger relationships between our first responders and the communities they serve.
- The Board of Directors voted to expand coverage to the first responders of Somervell County if sufficient funds could be raised in Somervell County to offset the cost of coverage. We are currently actively fundraising in Somervell County and are within \$6,000 of raising the necessary funds to be able to fully cover the first responders of Somervell County.
- The Board of Directors has also voted to explore expanding coverage to the first responders in the City of Mansfield for those areas outside of Johnson County.
- The Board of Directors is also exploring the long range feasibility of bringing in the first responders of Hill County. This is a very rural county with many volunteer first responders.

As you can see, The Chisholm Trail 100 Club has a bright future ahead. We continue to pray that our services will never be needed, but history has shown that the world is a dangerous place and that our first responders put their lives on the line day in and day out to protect and serve us. Please continue your support The Chisholm Trail 100 Club through your membership, donations and dedication as we support our first responders. Sincerely,

# LIFETIME ACHIEVEMENT AWARD – BOB ALFORD

SHERIFF OF JOHNSON COUNTY

The much loved Johnson County Sheriff was first elected into office over 19 years ago. Since then he has become a fixture within the community, serving as advisor on the Chisholm Trail 100 Club Board of Directors as well as many other organizations throughout the community such as Child Advocacy Center and Cowboys for Kids, Johnson County Sheriff's Posse and many more. His long career in law enforcement has seen many highlights. He made headlines when he hosted late night talk show host, Conan O'Brien, as O'Brien attempted to assume the role of a Texas Sheriff's Deputy. Alford also made an appearance on the Conan Show. Alford also made headlines nationwide when he posed as a hit-man in order to catch a would-be killer. In 2006 he led the search for 2½ year old Kevin Brown, who has been missing for three days; Kevin was happily recovered after a



helicopter search, thanks to Sheriff Alford's tenacity. Sheriff Bob Alford has led hundreds of deputies to thousands of arrests during his time in office, as well as assisted countless families through some of the worst days of their life. In April 2011 he was onsite when Deputy Clifton Taylor was killed in the line of duty, grieving with the family as well as managing the scene. Johnson County could not be more fortunate to have a man like Bob Alford at the helm.

# CHISHOLM TRAIL 100 CLUB AWARD—DAVID FEUCHT AND NICK GRACE

BURLESON POLICE DEPARTMENT



On Friday, December 17, 2014, around 12:00pm, a call came in to Burleson Police Department reporting a suspicious person at the Wells Fargo Bank on Renfro Street. Detectives Nick Grace and David Feucht responded. Upon entering the scene, they noticed the man described in the call outside the 7-Eleven convenience store. As they approached, the person opened fire on the two detectives. Nick Grace, a 19 year veteran of the department, was struck in the leg, while David Feucht, a 23 year veteran of the department, was struck by two bullets in the torso. The officers returned fire, but did not strike the suspect. As patrol officers closed in, the suspect was taken into custody without further incident. Both officers were rushed to JPS hospital in Fort Worth, where Grace was treated and released and Feucht underwent emergency surgery and was admitted for several days. These officers displayed tremendous courage and strength under fire, we are privileged to honor these detectives with the Chisholm Trail 100 Club Award.

# MEET OUR SPEAKER – JOE TORRILLO

Joe Torrillo was a 25 year Lieutenant with the NYC Fire Dept. who is now retired on disability. He spent the first 15 years of his career in Engine Company # 10, across the street from the South Tower of the World Trade Center. While recuperating from a severe injury on New Years Eve of 1996, Joe was assigned to convalesce in the office of fire safety education. Eight months into this "light-duty" position, Joe was ultimately named the Director of this public-based program. In his new position, Joe would co-design a children's state-of-the-art fire safety learning center, which opened in October, 2000.



This new venue, "The Fire Zone," in the heart of Manhattan, was nominated and won the coveted "THEA" award at the Emmy's in 2002. Shortly thereafter, in January of 2001, Joe worked on a project with Fisher-Price Toys to help design a new children's "action figure", which was part of their line of "Rescue Heroes". This new action figure was named "Billy Blazes" and was a likeness of a NYC Firefighter, who was an addition to their other "Rescue Heroes". In conjunction with the Executives of the Fisher-Price Corp., Joe chose the "Fire Zone" as the location for the press conference to introduce "Billy Blazes", and then keeping with a safety theme, ironically chose the date of September 11, 2001, because 9/11 is the Emergency phone number in New York City.

On the way to the press conference, that was set for 9 a. m., Joe was about an eighth of a mile away from the World Trade Center, when American Airlines Flight #11 struck the South Tower at 8:46 a.m. Joe diverted to the scene to render assistance.

Three minutes after donning borrowed bunker gear, at 9:03 a.m., the second jet, flew over Joe's head and slammed in to the South Tower. With a background in Structural Engineering, Joe made an immediate assessment that everyone above the fire was doomed to death, and the buildings would collapse. While Joe was involved in the rescue operation, the South tower fell at 9:59 a.m. Joe was buried alive with a fractured skull, broken ribs, broken arm, crushed spine and heavy internal bleeding. Shortly after being found alive in the rubble, they removed Joe on a long spine board and placed him on the deck of a boat on the Hudson River, with the expectation of getting him to a hospital.



As emergency personnel were holding his split scalp together, the North Tower fell and buried Joe alive again. He was alone in the engine room. About 45 minutes later, Joe was once again rescued from the debris, and taken across the Hudson River, where he awoke in a hospital room at the Jersey City Trauma Center in New Jersey. Because he was wearing a borrowed set of firefighting clothing with the name Thomas McNamara, Joe was misidentified by that name, and Joe was declared missing for 3 days. By the time the sun set on the evening of September11, 2001, Joe had miraculously survived the collapse of both Towers, but with life-long injuries.

Today Joe Torrillo travels the world as a professional speaker with a quest to make our country the "Re-United States of America."



Competition itself. The VIP party was hosted by Board Member, Mike Erinakes at MAAD H Ranch. Auction totals from the Party are an estimated \$41,000.00. This year's party highlights were the GNAT shooting game, in which a remotely controlled airplane flies over the shooters presenting a moving, tannerite loaded target, and a surprise auction item, basketball shoes worn and signed by Dallas Maverick Dirk Nowitzki and a game ball signed by the entire Maverick's team!
