



## CHISHOLM TRAIL 100 CLUB'S MAAD Hunter Venture Capital Group, Inc. Scholarship

The MAAD Hunter Venture Capital Group, Inc. Scholarship, is intended for children of active First Responders in the coverage area of Chisholm Trail 100 Club to pursue higher education for whichever field of study they desire.

### Application Guidelines

#### Award Range:

- A \$1,000 award for one student per year.
- Scholarship is renewable for 4 consecutive years with a GPA of 2.5 or better.
- The number of scholarships funded will depend upon available funds.

#### Applicant Eligibility:

- Graduating Senior
- MAAD Hunter Venture Capital Group, Inc. Scholarships are limited to children\* of active First Responders in the coverage area of Chisholm Trail 100 Club.
- The MAAD Hunter Venture Capital Group, Inc. Scholarship is applicable for use at post-secondary school or institution that requires a high school diploma or Graduate Equivalent Degree (G.E.D.) for admission. This could include any public or private: four-year accredited college or university; two-year accredited college; or vocational-technical college or a training institution.

#### Application Deadline:

- The last Tuesday in March.

#### Recipient Requirements:

- Recipients must adhere to all MAAD Hunter Venture Capital Group, Inc. Scholarship guidelines.
- Recipients will be asked to attend the Chisholm Trail 100 Club Annual Membership Luncheon for presentation of scholarship in July of the scholarship receiving year.



**Application Review:**

- Applications will be reviewed by the Scholarship Committee appointed by the Board of Directors for the Chisholm Trail 100 Club. The potential award recipient(s) will be presented to the Board of Directors for final approval. All decisions are final.

**Application Requirements:**

- Application must be from a child of an active First Responder in the coverage area of Chisholm Trail 100 Club.
- Application must be completed with required documents and received by the deadline set forth by the MAAD Hunter Venture Capital Group, Inc. Scholarship.

**NOTIFICATION OF SCHOLARSHIP AND AWARD DISBURSEMENT:**

The recipients will be notified approximately 2 weeks after the scholarship deadline. The scholarship award year will be defined as the 12-month period specified in the award. Scholarship award money will be deposited by the Chisholm Trail 100 Club on behalf of MAAD Hunter Venture Capital Group, Inc. with the university, college, or institution of higher learning to which the student is admitted, accepted, and which the student will attend. The award money is credited to an account established in the individual's name at the school. The funds can be used by the recipient for: fees or charges required for tuition; while attending school; and expenses for text books, course work, lab fees and other materials as required by a course instructor (e.g., goggles art/drawing supplies, glass slides, etc.) for required course assignments or projects.

**\*\*"Child"** is defined as any natural, adopted, or dependent child or stepchild or if the child is not a biological or adopted child, was claimed as a dependent on the federal income tax return of a First Responder, in the Chisholm Trail 100 Club Covered Service Area, who is at the time of the application 18 years old or under, or over 18 and a full-time student.

1. State your name, address, phone number and other contact information.

3. What area of academic concentration will you pursue?
4. List clubs and organizations in which you have participated in during your high school years. Include offices held in these organizations. Include school and community organizations.
5. List all your volunteer activities and community service hours you have donated during high school.
6. List honors and awards received during your high school years.
7. Are you currently employed? Where? How Long? Why are you working?
8. Attach a copy of your high school transcript with your courses for the first semester of the 12<sup>th</sup> grade. Ensure that your SAT, ACT, GPA, rank and attendance record are included on the transcript or attach a copy of the necessary documentation.
9. Attach a letter of recommendation-please no letters from your parents or family.
10. Please write an essay of no more than one page describing your educational and career goals and what you hope to achieve with the secondary education using the MAAD Hunter Venture Capital Group, Inc. Scholarship fund.
